The contracting party must be physically present when the mandatory verifies his/her identity.

## Documents or pieces of identification accepted for identification by a mandatary:

- Passport
- · Driver's licence
- · Health insurance card issued by a Canadian province
- · Permanent Resident Card (Canada)
- Any other government-issued identification document or photo ID

An identification document issued by a foreign country is also acceptable, as long as it is the equivalent of an acceptable Canadian document. For example, a valid foreign passport is acceptable.
